

(Ministry of Labour, Immigration and Population announcement on new visa rules.)

## Amendments of the terms and conditions for visa applications broken down according to the visa categories.

In order to enable foreigners to conveniently apply for a visa under the currently permitted new 12 visa categories for Myanmar, the following amendments of the terms and conditions for visa applications will start to be implemented on 1<sup>st</sup> December 2016.
