Welcome to a new edition of our newsletter.

#### 1. Draft of a new Myanmar Gemstone Law

We have uploaded an English translation of the draft of a new Myanmar Gemstone Law (<a href="http://tinyurl.com/y8blbamc">http://tinyurl.com/y8blbamc</a>) which was published in the state-owned press from 11 to 14 March 2017.

If enacted, the law **will replace the Myanmar Gemstone Law of 1995** (<a href="http://tinyurl.com/y9vpyapq">http://tinyurl.com/y9vpyapq</a> - the English translation does not take account of two amendments that have been made since).

As the law of 1995, the draft **disallows foreign investment in gemstone extraction** (although we are of the opinion that foreigners can act as service providers to local holders of a production permit).

Foreign investment (in a joint venture) in the "making of finished gemstones, manufacturing of jewelry and selling of raw gemstones, finished gemstones and jewelry" is presently allowed, but requires the approval of the Ministry of Mines and Natural Conservation and the Union Government. The draft removes the "selling of raw gemstones" from the list of allowed activities.

The draft defines a company as a "Myanmar company formed under the Myanmar Companies Act or a company formed solely with Myanmar citizens under the Special Company Act, 1950." As our readers are aware, a new Companies Law is presently being discussed which will, if enacted, provide for companies with foreign shareholders to be treated as Myanmar companies if foreign ownership does not exceed a (still unspecified) threshold. It remains to be seen if this will have an impact on the prohibition of foreign investments in gemstone extraction.

The draft provides for licensing procedures only for mid-scale, small-scale and manual gemstone production. The intention seems to be to disallow large-scale production, i.e. extraction in an area of more than five acres.

Furthermore - presumably in response to criticism that the State did not profit much from the lucrative gemstone business in the past -, the draft **specifies the rates of the gemstone tax and service fees**. More precisely, it provides for a gemstone tax of 20% of the value of raw rubies, sapphires, jades and diamonds and 10% of the value of other raw gemstones, and service fees of 3% of the sales price of raw gemstones and 1% of the sales price of processed gemstones.

The draft furthermore contains obligations of gemstone miners to limit environmental and social impact, reconstruct the site after the end of the production, establish a budget of 2% of the investment for social purposes and cooperate in investigations of the Myanmar Extractive Industries Transparency Initiative (MEITI) and local organizations for environmental conservation.

### 2. Implementation of the new Myanmar Investment Law

In a good sign, the MIC has recently issued the first "endorsements", i.e. permission to use land long-term and/or enjoy tax incentives. This means that the new Myanmar Investment Law is being implemented and, given the apparent speed with which the endorsements were rendered, that the endorsement procedure is, as intended, less cumbersome than the MIC permit procedure (which the new law has retained only for very large projects).

In this context, the MIC advises that **all investors carrying out** activities specified in MIC notification 15/2017 (<a href="http://tinyurl.com/yasp99dy">http://tinyurl.com/yasp99dy</a>, so-called "**restricted activities**") **must inform** the MIC or the respective State or Regional Committee Office about this until 29 March 2019, even if the investor has an existing MIC permit (<a href="http://tinyurl.com/y7r6ydw9">http://tinyurl.com/y7r6ydw9</a>).

#### 3. Form E

On 2 May 2017, DICA issued a list of companies established in the 2014/15 financial year that still have to file their first form E (which is a list of shareholders and directors and other corporate information): <a href="http://tinyurl.com/y9v2varh">http://tinyurl.com/y9v2varh</a>. Representatives of companies founded in the 2014/15 financial year should check whether their company is on this list and take appropriate action, i.e., either file form E or inform DICA if their company is erroneously on this list.

#### 4. New laws

Among the new laws and drafts of new laws that were recently published in the state-owned press, the **draft of a new Registration Law** is noteworthy. It will, if enacted, replace the Registration Act of 1908. Unfortunately, the draft contains, as the present law, the requirement for lease agreements for a term in excess of one year to be registered. Foreign-invested companies, even those with an MIC permit, quite often find it difficult to comply with this requirement as registration officers quite often refuse to register lease agreements with a foreign party for a variety of reasons.

#### 5. Sale of business assets

An acquaintance of ours is selling the assets of his business renting out office space. have assets or a paid-up capital of USD 1 billion in total; and (iii) have an S&P rating of B+ or higher. The initial license fee is USD 30,000; the annual renewal fee USD 10,000. Interested companies must offer a 10% share in the Myanmar operation ("compulsory cession of minimum 10%") to state-owned Myanma Insurance.
