2. Corporate income tax rate for YSX listed companies reduced from 25% to 20%

PWC called our attention to Ministry of Planning and Finance Notification 76/2017 dated 26th July 2017. According to Section 31(b)(2) of the Union Tax Law 2017, the Ministry may grant exemptions and relief from corporate income tax for listed companies in order to develop the Yangon Stock Exchange. In the Notification, the Ministry:

- reduced the corporate income tax rate for listed companies from 25% to 20%;
- allows listed companies with unreported income from two years preceding the listing to pay the hitherto unpaid corporate income tax and escape fines and prosecution under the Income Tax Law.

Presently, First Myanmar Investment Co., Ltd., Myanmar Thilawa SEZ Holdings Public Ltd., Myanmar Citizens Bank Ltd. and First Private Bank Ltd. are listed on the Yangon Stock Exchange.

The Notification applies already to this (2017/18) financial year. As a result of the Notification, other companies contemplating listing may speed up the process as listed companies now enjoy a considerable tax advantage over their competitors.
