**Notification No. 57/2018
14th Waxing Day of Nattaw, 1380
(21 December 2018)**

The Ministry of Commerce hereby issues this notification according to the power conferred by the Export and Import of Goods Law, section 13 sub-section (b).

Allowing foreign companies, international non-governmental organisations and branches of foreign companies to import office equipment and goods required for their services

1. The Ministry of Commerce allows, from the date of this notification, foreign companies, international non-governmental organisations and branches of foreign companies to import office equipment and goods required for their services for them to operate more conveniently.
2. With regard to the import from abroad, foreign companies, international non-governmental organisations and branches of foreign companies shall comply with the following terms:
 - (a) Shall apply as prescribed for an exporter and importer registration certificate if they are a company or branch, or shall apply for a registration number made for export and import if they are a non-governmental organisation;
 - (b) shall only import office equipment;
 - (c) shall only import goods that are required for their services if they are providing services;
 - (d) shall not resell the imported goods;
 - (e) shall, when importing, comply with the terms specified for each type of goods by the relevant department;
 - (f) shall submit a letter of undertaking stating that the goods are office equipment or required for their services, together with a description of usage based on the types of office work or service.
3. If the goods imported by foreign companies, international non-governmental organisations and branches of foreign companies are not used as described in the letter of undertaking, but

discovered to have been resold, the exporter and importer registration certificate or the registration number shall be revoked and further import applications shall be rejected.

4. The terms for importing office equipment and goods required by foreign companies, international non-governmental organisations and branches of foreign companies for their services so that they can operate more conveniently may be amended and announced as necessary.

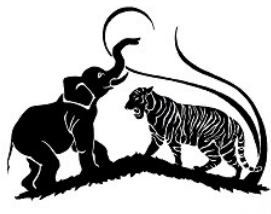
