Government of the Republic of the Union of Myanmar President's Office Executive Order No. 1/2020 7th Waning Day of Nayone, 1382 (12th June 2020)

Order Concerning the Union Tax Law

This executive order is hereby issued according to the authority conferred by section 32 Union Government Law in order to implement the COVID-19 Economic Relief Plan so as to alleviate the damage caused to businesses by COVID-19.

- 1. This order shall be called the Order Concerning the Union Tax Law.
- 2. This order shall have effect for the 2020/21 tax year.
- 3. The terms included in this order shall have the same meanings as in the Income Tax Law and the 2019 Union Tax Law.
- 4. The following tax reliefs are granted in order to achieve the goal no. 2 in the COVID-19 Economic Relief Plan, to promote investment, trade and banking sectors, and thereby alleviating the damage caused to the private sector -
 - (a) Right to enjoy 10% of the additional wages and salaries during the 2019/20 income year as non-refundable tax credit.
 - (b) Right to deduct 125% of the additional wages and salaries paid during the 2019/20 income year as expenses.
 - (c) Right to enjoy 10% of the total value of the additional capital equipment that were increased by investment during the 2019/20 income year as non-refundable tax credit.
 - (d) Right to enjoy 125% of the total depreciation of the additional capital equipment as "one time depreciation".
- 5. The Ministry of Planning, Finance and Industry shall issue procedures concerning the tax relief prescribed in paragraph 4 and eligible businesses with a notification.
