- Digital businesses and protection of intellectual property

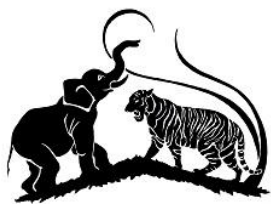

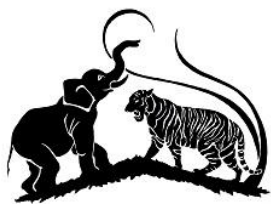
