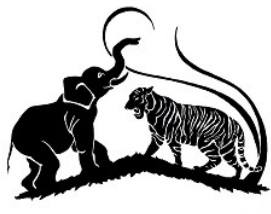

1. Discussions were held at the Foreign Exchange Supervisory Committee Meetings 26/2022 and 27/2022 regarding exemptions under para. 3 of the referenced CBM Notification.
2. According to the decision of the Foreign Exchange Supervisory Committee Meetings No. 26/2022 and 27/2022, the following matters are not included in the CBM Notification 12/2022:
  - (a) Foreign currency in the foreign currency account of Woori Bank Representative Office opened with Myanma Foreign Trade Bank;
  - (b) foreign currency from the respective foreign currency account of the Special Economic Zone Management Committees and their subordinated companies: Thilawa SEZ Management Committee Company Limited, Kyaukphyu Special Economic Zone Project Development Company Limited, Kyaukphyu Special Economic Zone Deep Sea Port Company Limited, and Dawei SEZ Management Committee Company Limited;
  - (c) Export-Import Bank of India;
  - (d) China National Oil Corporation - CNUOC (Myanmar Branch);
  - (e) Panjab [*sic*] National Bank Yangon Representative Office.
