Subject: **Export of rice, pulses, corn and oilseeds across the border**

- (2) Telegram no. 0108 of the Import and Export Division of the Department of Trade dated 1<sup>st</sup> July 2022
- 1. Meeting no. 27/2022 dated 30<sup>th</sup> June 2022 of the Foreign Exchange Supervisory Committee decided to allow the export of rice, pulses, corn and oilseeds across the border only for USD and to bring pricing in line with export pricing in maritime trade.
- 2. Meeting no. 11/2022 of the Management Committee of the Ministry of Commerce decided that, in the case of export of goods, the export earnings must be received in Myanmar within 45 days and the export license shall be valid for 1 month.
- 3. The export of oilseeds has been suspended since 8<sup>th</sup> May 2022; the suspension will be lifted only with the approval of the Minister's Office of the Ministry of Commerce to which the matter has been submitted.
- 3 [sic]. Therefore, the responsible persons of the relevant OSS [one stop service] department; the Muse-Namkham Border Traders Association; the Rice Commodity Exchange; and the Pulses, Corn, and Sesame Agricultural Commodity Exchanges are notified to follow the instructions concerning the export of rice, pulses, corn and oilseeds across the border.
