3. When submitting a letter of expression of interest (LoEI), citizen entrepreneurs and cooperative societies wishing to invest shall submit 4 hard copies (1 original and 3 copies) and a soft copy labelled "Submission of Expression of Interest for 10 Onshore Blocks of Myanma Oil and Gas Enterprise" and attach the company's articles of association (AOA) and Memorandum of association (MOA) or the company's constitution; the company registration certificate (certificate of incorporation); the company's annual report for the last 3 years; the company's financial statements or financial reports for the last 3 years; description of oil industry experience (detailed track record); [details of] the company's industry experts; [papers showing that] the company's structure is composed of knowledgeable persons; and [other] relevant documents. The expression of interest shall be submitted either in person or through a representative no later than 12th August 2022, 12:00 noon, and be addressed to:

- 4. Applicants submitting expressions of interest are not allowed to submit their proposals by post or by e-mail.
- 5. The Oil and Gas Planning Department will make a presentation for those wishing to submit expressions of interest in Nay Pyi Taw, Office No. 6, two weeks after the call for expressions of interest was published in the newspaper, on 26th July 2022 at 13:00; the presentation will cover basic information needed to submit an expression of interest.
- 6. A shortlist of submissions of interest will be made. Citizen entrepreneurs and cooperative societies that are on the shortlist will be given a free briefing by the Geology/Geophysics Department of the Myanma Oil and Natural Gas Enterprise on the geological information related to the tendered blocks.

- 7. The Oil and Gas Planning Department will answer questions on the standard terms and conditions in the JOA contract so that citizen entrepreneurs and cooperative societies on the shortlist may submit proposals for the block that they want to operate.
- 8. Citizen entrepreneurs and cooperative societies on the shortlist must submit the terms and conditions that they wish to propose in the proposal form.
- 9. The proposed block and the related terms and conditions will be selected based on a review of the technology owned by the bidder, the bidder's financial strength, whether the bidder has operational experience, and whether the bidder is compliant with the rules and regulations.
