

# Notice that an application for a new overseas employment agency license shall be filed by the managing director at the Department of Labour (Headquarters) in Nay Pyi Taw together with the following information:

- (a) Application letter submitted to the Department, signed by the managing director of the company that is applying for the overseas employment agency license;
- (b) Company registration certificate from the Directorate of Investment and Company Administration, Ministry of Investment and Foreign Economic Relations;
- (c) Company profile submitted and approved by the Directorate of Investment and Company Administration in the application process for registration [probably the "company extract"];
- (d) Minutes of the board of directors' meeting having appointed the managing director;
- (e) Resumes of the directors included in the company profile (passport photo taken within the last 6 months / signature); copy of the national registration card; copy of the household list; original police recommendation letter; original ward recommendation letter;
- (f) List/proof of immovable property in the sole name of the managing director, worth at least MMK 100 million;
- (g) A minimum of MMK 100 million have to be deposited in the sole name of the managing director; after obtaining the overseas employment agency license, an updated bank statement showing the deposit of MMK 100 million has to be submitted to the Department monthly for a period of 6 months, and after the 6 months period, the deposit may be used; each time a license renewal application is submitted, a bank statement with MMK 100 million has to be submitted [again].
