#### Determining the tariff rate reduction

The Ministry of Planning and Finance hereby issues this notification in exercise of the authority conferred by section 3, sub-section (d) of the Tariff Law.

- 1. In order to develop the use of electric vehicles in the Republic of the Union of Myanmar and related industries, the tariff rates specified in the 2022 Myanmar Tariff List have been reduced to zero percent in accordance with the decision of the Union Government for the following types of battery electric vehicles (BEV) imported completely built up (CBU), completely knocked down (CKD) or semi-knocked down (SKD) -
  - (a) Road tractor for a semi-trailer;
  - (b) passenger vehicle for 10 or more persons, including the driver;
  - (d) truck;
  - (e) passenger vehicle;
  - (f) three-wheeled passenger vehicle;
  - (g) three-wheeled cargo vehicle;
  - (h) two-wheeled electric motorcycle;
  - (i) two-wheeled electric bicycle;
  - (j) ambulance;
  - (k) prison van;
  - (I) hearse;

- (m) with regard to electric vehicles referred to in sub-clauses (a) to (k), accessories for electric vehicles (such as charging station equipment, charging system equipment) with technical approval for importation by the Ministry of Electric Power, and spare parts for electric vehicles in the attached list with approval for importation by the Ministry of Industry.
- 2. This notification shall be in effect from 2 November 2022 to 31 March 2023.
