Instructions on procedures to be followed with respect to overtime in factories and workshops

Factories and General Labour Law Inspection Department ("FGLLID") offices to which factories and workshops must apply for overtime permission

Sr.	Number of workers in the factory or workshop	Department to apply to
1	Factories or workshops with up to 500 workers	Relevant township, district or industrial zone FGLLID offices
2	Factories or workshops with 501 to 1,000 workers	Relevant district FGLLID office or industrial zone FGLLID offices
3	Factories and workshops with 1,001 and more workers	Relevant regional or state FGLLID offices

> Details to be submitted by factories and workshops when applying for overtime permission

- (a) Factories and workshops must submit the application for overtime permission 7 days in advance.
- (b) Undertaking from the business owner or manager certifying that it is necessary to work overtime as allowed.
- (c) Documentation of the consent of the workers who will work overtime.
- (d) Letter from the owner or manager from the factory or workshop acknowledging that he knows that he will be prosecuted if work in addition to the permitted overtime is done.

Allowed overtime hours in factories and workshops

Sr.	Days on which overtime is worked	Overtime hours		
Factories that do not have to operate continuously				
1	Monday to Friday	3 hours		
2	Saturday	5 hours		
Factories that have to operate continuously

Sr.	Days on which overtime is worked	Overtime hours
1	Monday to Saturday	2 hours 40 minutes
2	If overtime should be worked on Sundays or gazetted holidays, this must be done in compliance with the rules and regulations of the FGLLID.	

Formulas for calculating overtime pay

(a) For workers receiving a monthly wage

(b) For day labourers

(c) For part-time workers

- No worker shall work more than 44 hours per week.
- As an exception, workers working in the following processes may work up to 48 hours per week
 - (a) Electricity supply business;
 - (b) ice machines;
 - (c) petroleum refinery;
 - (d) timber dehumidifying business;
 - (e) water or oil pumping stations;
 - (f) wind or gas power stations;
 - (g) chemical industry; mills for extracting oil from crops;

(h) sugar mills.

(If the weekly working hours are specified in any other law in force, the working hours shall be calculated according to that law.)
