The Intellectual Property Agency has issued this notification in exercising the powers conferred by section 106(d) Trademark Law with the consent of the Ministry of Commerce.

Determining the service fees for an application for trademark registration

1. The fees to be paid for the various types of services regarding an application for trademark registration in accordance with the Trademark Law are set as follows according to section 8(j) Trademark Law with the consent of the Union Government:

 - (b) The fees specified for requests with TM-12 and TM-13 are for one trademark only.
 - (c) The fees specified for requests with TM-3, TM-4, TM-6, TM-7, TM-8, TM-9, TM-10, TM-15, TM-16, TM-17 and TM-18 are for one request only.
- 3. The fees for the various types of services regarding an application for trademark registration will be revised from time to time and made public accordingly.
