- Regarding matters to be followed when associations to be registered under sections 7 and 17
 Registration of Associations Law apply for a recommendation, letter no. 1/Su 40/2023 (Monthly)
 of the Union Judicial Supervision Office was already published on 5 January 2023.
- 2. According to the aforesaid announcement, it was found when reviewing the applications that some of the applications had incomplete information and that the stamps of the associations were similar. The Union Judicial Supervision Office will review the applications of associations for recommendation and issue a recommendation in accordance with relevant laws, provisions, rules, and the specifications of the Union Registration Board of the Ministry of Home Affairs.
- 3. In addition, associations applying for a recommendation are hereby notified to submit the following particulars in full with the application form:
 - (a) Activities of the association;
 - (b) the purpose and work programme of the association and a statement on its ability to assist in legal affairs and assist the judiciary and justice;
 - (c) name, stamp, mark, and uniform design of the association;
 - (d) undertaking that the aforesaid name, stamp, mark and uniform design is, according to section 28(b) of the law, not identical or similar to (1) a name, stamp, mark and uniform design officially used by the state or government departments and organisations, (2) the name, stamp, mark and uniform design of an association that has received a registration certificate or of any organisation established under any other law in force, and (3) a name suggesting that its bearer represents the whole state, an ethnic group, all ethnic groups, or an entire industry.
