1. Online sales business registration fees

On 28 December 2023, the Ministry of Commerce under the State Administration Council ("**SAC**") determined the fees for the registration of <u>online sales businesses</u> (e-commerce businesses) as follows:

2. Permissible manufacturing years of vehicles that may be imported

On 21 December 2023, the SAC's Ministry of Commerce announced the permissible manufacturing years of vehicles that may in principle be imported in 2024, but warns that policies restricting imports remain in place.

Notification for the year 2024 determining the year of manufacture when importing motor vehicles from abroad

1. The year of manufacture when importing motor vehicles from abroad is determined as follows for the year 2024:

(a)	Private cars	2023-2024
(b)	Commercial vehicles (lorries/vehicles for passenger transport)	2020-2024
(c)	Fire engine/ambulance	2015-2024
(d)	Commercial vehicles other than for transport <i>[lit., "machines"</i>]	2015-2024

- 2. Only left-hand drive vehicles may be imported when importing vehicles listed in para. 1 (a)-(c) above.
- 3. Commercial vehicles *[lit., "machines"]* in the attachment that are not used for driving on public roads may be imported if they have been manufactured in the last 15 years (from 2010 onwards).
- 4. The statements in this notification may only be understood as the regular announcement of the determination of the manufacturing year of vehicles whose import is *[in principle]* allowed in a calendar year as per procedure. Regarding the importation of motor vehicles, it is hereby notified that the policies currently in place will continue to be applied without any change.
